Takeaways

- The MBNEP is updating its Comprehensive Conservation and Management Plan this year and we will be reviewing and updating the GNC goals and objectives as a part of this process.

Commissioner Skip Gruber welcomed members and each gave a quick introduction. The meeting was called to order at 7:51 a.m. Commissioner Ludgood moved to approve the minutes from the previous meeting, the motion was seconded by Mayor Tom Williams, and the minutes were approved.

Eliska Morgan gave an update on NFWF funding and RESTORE activities. They are in the sixth round of putting proposals into NFWF and the board votes in November. Alabama RESTORE released its draft Multi-Year Implementation Plan in April for a 45-day public comment period, with a public meeting on May 23rd to take comments. Comments can also be submitted online at <http://restorealabama.org>. The State expenditure plan (Bucket 3) is under development and anticipate its release in mid-summer and will undergo the same process as the MIP before it is finalized. Bucket 1 MIP activities will be entered into the system for individual grants, with the funding for those projects going out the first quarter of 2019.

Next Patti Powell gave an update on the Federal RESTORE Council. MBNEP's Watershed Management Planning grant funding will be awarded soon. The NRDA Draft Restoration Plan 2 includes 22 projects for a total of \$35 million. The comment period recently closed (May 7th). Once comments are reviewed

the Plan will be finalized. Merceria asked about the schedule for submitting project proposals to NFWF and Eliska said projects are generally selected in February for full proposals and review to be voted on at the November board meeting. Patti also said that projects can be entered into the portal at any time and you are encouraged to enter projects as early as possible to help the State better plan for which projects to put forward.

Commissioner Blankenship announced that Governor Ivey is hosting a restoration summit on October 11th (location has been tentatively set for Spanish Fort City Hall) for coastal Alabama. There will be a “Restoration 101” session aimed at those who are new to the process along with a more technical session for those who have been actively participating in this process. There will also be a larger public format meeting in the evening to provide information on the types of projects being funded and implemented through Alabama & Federal RESTORE, NRDA, NFWF. Please go to www.alabamacoastalrestoration.org to sign up for e-mail updates. Deadlines, release of a plan, meetings, and information on funding are all on the website.

Next, Justin McDonald with U.S. Army Corps of Engineers presented on the Alabama Coastal Comprehensive Plan (ACCP). The State of Alabama is working with the U.S. Army Corps of Engineers to develop a constituent informed, science-based coastal comprehensive plan to strengthen the economic, environmental, and social resilience of coastal Alabama for current and future generations. <http://www.sam.usace.army.mil/Missions/Program-and-Project-Management/Alabama-Coastal-Comprehensive-Plan/>

The scope of this process was to:

- develop a high-level planning tool for the State that identifies the vision (environmental, economic, social, etc.) of the citizens of Mobile and Baldwin counties.
- Determines if a plan already exists to address that vision
- Identifies future vulnerabilities to achieving that vision
- Highlights potential future planning considerations to increase resiliency

During the current phase of the ACCP, a coast-wide vulnerability assessment is being conducted to identify future risks due to sea level rise. During the first phase in the development of the ACCP, visioning exercises with various sectors of our coastal communities and the public were conducted. USACE is currently working on two versions of a GIS viewer. One version will be for the general public and another, with more technical features, for elected/municipal officials and resource managers.

Then, Christian Miller took us through the process of re-prioritizing the remaining watersheds. Members did clicker voting to rate from 1 to 5 the priority of the remaining watersheds for completion of Watershed Management Plans. Each watershed was represented by a map with evaluation criteria – whether it has protected lands, impaired waters, and the percent of urbanization, etc. We hope to finish all the remaining plans within the next three years.
