The Business Resources Committee of the Mobile Bay NEP met on Wednesday January 28, 2015. The meeting was opened by Co-chairs Jennifer Denson and Darrelyn Bender, welcoming the following members: Eliska Morgan, ADCNR; Wiley Blankenship, Coastal Al. Partnership; John Bender, Mcfadden, Lyons, and Rouse; and introducing new members Kristian Aboud, Wild Native Tourism; Ashley Jones, No. Baldwin Chamber of Commerce; Pfil Hunt, Harbour Financial; and Ben Stimpson, Scotch Gulf Lumber. Also in attendance were Cynthia Maddox and Ellen Faulkner with Lewis Communications. NEP Staff- Rick Frederick and Roberta Swann.

Mission of BRC: To advocate for streamlined regulations and balanced business practices that are in the best interest of the region's economic and environmental resources.

Takeaways:

- Updated the committee on current and future activities that the MBNEP is undertaking in watersheds on both sides of the bay.
- Introduced Lewis Communications as PR firm awarded the contract to conduct market research segment of the Create a Clean Water Future campaign. Reported on current status and membership of the CCWF.
- Committee will hold a workshop on March 18th to discuss next steps to incorporate the CCWF into the business community and begin implementing the Year 2 strategies of the CCMP using the CCWF in various watersheds.
- Introduced and discussed the Committee Membership/Responsibility Form. Members agreed to sign form once edited and finalized.

1). The meeting began with updates on Three Mile Creek restoration, Create a Clean Water Future campaign, and future watershed management plans funded by NFWF.

a). TMC updates and future projects-

- i. Planning for comprehensive invasive species eradication and management program.
- ii. Community mapping and climate adaptation planning partnership with MLK Redevelopment.
- iii. Trash free waterways project with EPA HQ to provide assistance with Seabees and trashboat demo.
- iv. Planning with Univ. of So. Alabama to include addressing sediment accumulation issues into their strategic and capital improvement planning.
- v. Mobile County Health Dept. received grant for project to build kayak launch and greenway around the Tricentennial Park area.
- vi. Nigel Roberts w/ City of Mobile to release RFP for conceptual trail plan for the entire greenway/blueway trail from headwaters to Mobile River.

b). CCWF- Introduced Lewis Communications as PR/Ad firm receiving contract- Beginning Jan. 1st to conduct market research segment of the Create a Clean Water Future campaign. Lewis has begun interview process for their "Dig" to provide recommendations for best strategy to reach the business community in addressing stormwater run-off. CCWF now has 28 organizations (7 new in 2014) who have signed the resolution.

c). Updates of Watershed Management Plans MBNEP currently overseeing-

- i. Completed and Implementating- Three Mile Creek, Eight Mile Creek, and D'Olive Watershed.
- ii. Currently in Development- Fowl River Watershed.
- iii. Funding received and to be completed over next 2 years- Bayou la Batre, W. Fowl River, Dog River, Appalachee/Tensaw River, Fish River, Wolf Bay, and Bon Secour.

2). Review of 5 Year Strategy.

Rick Frederick shared the 2104 accomplishments as outlined in the 5 year strategy of the CCMP by providing the # of tours, presentations, face-to-face meetings, contract with PR/Ad agency, etc. The update and numbers will be emailed to all BRC members as a separate attachment. Discussion also took place regarding 2015 goals. After a short sharing of ideas of ways to best reach the business community as it relates to stormwater run-off, it was decided the BRC would hold a 2 hour workshop in March to discuss our next steps. Tentative date and location is

March 18 from 10-12 in the Killian Room at the International Trade Center. Details and confirmation to follow.

3). BRC Committee Responsibility Form.

Co-chairs Jennifer Denson and Darrelyn Bender presented members with the Committee Responsibility Form.
