

## a. SAC:

- i. D'Olive monitoring framework developed & data collected
- ii. Brief update on harmful algal blooms from previous year
- iii. New surface Water Monitoring Plan from ADEM-involves more sampling over a larger area
- iv. Working group developed to identify what is missing from stressors & ecosystem
- v. Data to be housed at DISL

## b. PIC:

i. Watershed Management process planning – possibility of grouping 12 digit HUCs for management plans based on the following factors:



economy of scale, geographical proximity, similarity & common receiving waters

- ii. USACE presented on Interagency Working Group initiatives & AL Barrier Island Restoration Study
- iii. Watershed Comparison Tool in development by partners at Nature Conservancy (SAC & PIC work together on tool needs)
- iv. Fowl River plan complete with projects underway
- v. Bayou La Batre plan <sup>3</sup>/<sub>4</sub> complete and now on hold to include Dauphin Island and West Fowl River
- vi. Bon Secour plan in development & now includes Bon Secour River, Oyster Bay and Skunk Bayou
- vii. Dog River Watershed characterization underway
- viii. Fish River Stakeholder Workshop held & well attended
- ix. D'Olive Tiawassee project near completion; Joe's Branch under construction

  - i. Purpose: to re-establish the CAC Water Quality Program by engaging grassroots groups and educating citizens about the water quality issues related to their local watersheds.
  - ii. Goals: to increase citizen involvement in hands-on monitoring and its contribution to watershed planning; build capacity among grassroots groups through trainings and technology transfer
  - iii. Objectives:
    - 1. Establish target number for trained volunteers
    - 2. Assess equipment needs / chemical supply and demand

- 3. Location accessibility needs for volunteer monitors
- 4. Level of monitoring (types)
- 5. Training needs

#### 4. New Business

**a. Dr. Mimi Fearn** was appointed as Co-Chair. Dr. Fearn's professional background and water quality monitoring expertise will be a huge asset for the CAC moving forward in accomplishing its set goals and expanding the monitoring program.

#### b. Water Rangers Tool

Cade Kistler and Jason Kudulis presented the Water Rangers Tool as an option for entering in water monitoring data. The website for the tool is <u>http://app.waterrangers.ca/</u>. The tool offers a more user friendly approach to entering in monitoring data. The group agreed that the appearance of the tool along with the phone app option will help in attracting and retaining a younger audience for collecting and entering in data. Mobile Baykeeper has helped to fund the tool for our local area along with manipulating the development to include data specific to our coastal areas. Members of the CAC group requested that additional perimeters be added for input. Mobile Baykeeper will work with the developers to add the additional requested perimeters and has offered to help any group to get started using the tool.

#### c. Clean Water Future Website

Ben Brenner presented the updated Clean Water Future website. This new upgrade to the website offers numerous solutions to problems that exist with water quality for kids, adults, business, retail and restaurants.
