#### 1. Welcome and Introductions

Madison Blanchard opened the meeting requesting each virtual participant to sign-in through the chat box on the google meet platform. She reviewed the agenda for the meeting and introduced the co-chairs and the guest speaker, Dr. Judy Stout.

#### 2. Review and Approval of Minutes

Ms. Blanchard requested a motion to approve the minutes from the CAC's August 11, 2020 virtual meeting. Ms. Debi Foster made a motion to approve the minutes and Dr. Mimi Fearn second.

#### 3. Guest Speaker

Ms. Blanchard introduced the guest speaker, Dr. Judy Stout, who is a Master Gardener in Mobile County. Dr. Stout gave a presentation on native plant species found in coastal Alabama including the

benefits and ecological functions of native plants, and what to consider before selecting and planting native plants. Dr. Stout began by providing common definitions of 'Native Plants' and reviewing geographic areas also known as eco-regions. Dr. Stout states that links to eco-region maps can be found on the *Native Plant Resources and References* handout. A link to the handout is listed below. Due to internet connection issues, Dr. Stout's presentation was cut short while discussing the growth patterns of native tree species. Ms. Jenni Zimlich and Ms. Blanchard announced that MBNEP, Krewe of Kindness and the Town of Dauphin Island have partnered on an access project to install 270 feet of ADA beach mat on the

Dauphin Island West End Beach during the first week of December 2020. 200 feet will be installed on the sound side, and 70 feet will extend the existing mat on the Gulf side toward the water.

Ms. Blanchard informed meeting attendees that the 2021 CAC schedule will be developed in the upcoming weeks and asked for meeting topic suggestions. Suggestions can include but are not limited to (1)extensions of topics we've already discussed, (2)topics related to what we've already discussed or (3)new topics.
