### **Takeaways**

- The BRC has been updated on the status of various projects, including the Dauphin Island Oyster Park and the Coastal Alabama Fisheries Fund.
- The BRC has been briefed on the additional funds MBNEP will be receiving from the Infrastructure Bill.
- The alternative packaging subcommittee was reestablished.

Henry Perkins called the meeting to order at 2:06. Frank Smith made a motion to approve the previous meetings minutes. The minutes were approved.

### **Old Business**

#### **Coastal Alabama Fisheries Fund update**

- Frank Smith updated the BRC on CAFF
- Fund is up and running, ready to receive applications
- Community meeting covering CAFF, monitoring, and restoration efforts is being planned for the Coden area

#### **Dauphin Island Oyster Park update**

- Eliska Morgan updated the BRC on the Dauphin Island oyster park
- Continues to be a long-term initiative
- Need to coordinate more with the Island
- Possibility to tie this park into the loan fund in the future to help with early success

### **Infrastructure Bill**

- Roberta Swann presented on the Infrastructure Bill
- MBNEP will have approximately \$795,000 to invest annually for the next 5 years
- EPA wants to see a focus on “Transformational Projects”
- Funding can be carried forward and must be project related
- Priorities for the funding include environmental justice and community resilience
- We are in the process of determining what the best use of the money is and working with the Finance Committee to develop recommendations
- One possibility: a living shorelines fund, possibly develop a match program with coastal property owners, investing in the shorelines ecosystem as a whole
- Another possibility: dirt road paving, the County is doing work on this but may not have enough money to fund it all, and dirt roads contribute significantly to sediment runoff into waterways
- A third option: green infrastructure improvements in public housing campuses as they begin redevelopment from deferred maintenance. There is a lot of opportunity for this and EPA thinks it could be a national model if pulled off correctly. Would bring EPA and HUD together in a unique way as there is generally little overlap between the agencies.

### **New Subcommittee Establishment**

- Henry Perkins called for a re-establishment of the Alternative Packaging subcommittee
- Frank Smith, Colette Boehm, Jeanette Kelson and indicated interest in being involved

### **Other Discussion**

- Henry Perkins discussed goals for 2022
  - Grow the BRC
  - Speak less at meetings

- Develop an Alternative Packaging project
- Eliska indicated a desire to meet in person, to trigger good conversation and be more productive
- Rusty Grice mentioned Oyster South's symposium coming up, with sessions on alternative packaging, workforce development, ecotourism

A motion to adjourn was made and seconded and the meeting ended at 2:44.
