The work includes the restoration and rehabilitation of approximately 1,296 linear feet of perennial stream in Daphne, Alabama. In addition to stream restoration and stabilization the project will include selective clearing, grubbing, excavation, grading, installing stream level structures, installation and maintenance of erosion control, and emergent and riparian planting and landscaping. Stream level structures include log sills, rock j-hooks, log drop structures, and constructed boulder riffles. Floodplain structures include log sills and vegetated riprap. Erosion control includes mulch, coconut coir fiber matting, temporary seeding, and bypass pumping. Planting and landscaping include installation of both wetland and upland seed mixes, live staking, bare root planting, and plugs. stream channel and floodplain.
